# PHOENIX-GOODYEAR AIRPORT, ARIZONA

- 1. SUBJECT: Utilization of Rainbow Valley Practice Area & Communication Procedures
- 2. PURPOSE: Establish training areas and areas of avoidance leading to safe operations for Practice Area and 56th Fighter Wing aircraft.

# 3. RESPONSIBILITIES:

- 3.1. UAA, LAT, and GAF instructors will ensure students are familiar with and comply with this MOU.
- 3.2. LUF will ensure controllers are familiar with and comply with this MOU.

#### 4. PROCEDURES:

- 4.1. UAA, LAT, and GAF shall:
  - 4.1.1. Ensure aircraft <u>NOT</u> requesting flight following with LUF remain at or below the designated altitudes within the prescribed practice/transition areas defined in **Attachment 1**. Aircraft operating within the defined areas shall maintain 2-way radio communications on the practice area frequency 128.925.
    - 4.1.1.1. Along the SR85 corridor (from south of Farm AG airport (north) to Lakeside Airpark (south) and between the foothills on the east and west sides: No maneuvering allowed. Transitions ONLY across this area are authorized at or below 3,500' MSL.

- 4.1.1.2. In the area bounded by I-8 to the south, the Cattle Sheds to the north, an eastern border straight south of GYR Airport to the Tire Farm, and the SR85 corridor to the west: Maneuvering is authorized at or below 4,500' MSL. Note: This restriction excludes the area inside the Aerobatic Box.
- 4.1.2. Aircraft requesting flight following from LUF while operating within the practice area must have the ability to maintain 2-way communication with LUF on 125.45 and practice area common frequency 128.925 to ensure appropriate traffic deconfliction.
- 4.1.3. Ensure aircraft operating in areas other than the practice or transition areas in **Attachment 1** requesting radar services establish 2-way communication with LUF on 125.45 and state intentions. This includes practice instrument approaches, cross-country flights, or maneuvers in other areas under LUF control.

# 4.2. LUF shall:

- 4.2.1. Provide VFR traffic advisories to aircraft requesting flight following as an additional service.
- 4.2.2. Provide suggested traffic deconfliction procedures when necessary (i.e., altitude restrictions, alternate locations, etc.).
